REPORT ON MAINTENANCE.

VELLOWDING GOLD DEVELOPMENT LAMITED.

REPORT NO. 1945/49.

Situation of Mine: 1 mile east of Mt. Falmer township (now practically deserted) and 9 miles by read couth of Yollowdine on the Southern Cross - Coolgardie railway.

Issued Conital of Company: 6808, 281.

Address: Yellowdine Gold Development Ltd., London House, 324 Murray Street, Perth.

Meintenance Commenced: June, 1944.

Average Amount per Colendar Month: (January to April, 1945).
2101.14.17, which included wages £65.8.3, stores (mostly petrol and charcoal for mine truck) £7.1.10, Mine Workers' Wellef Fund 6/-, rates 16/8d., insurance £18.11.4, Administration £9.10.10. These last three items have since been disallowed.

Basis of Maintenance: One Caretaker at £7.17.7 per week. One Caretaker at £7.19.1

Since April 1945, only one Chrotaker has been employed, and the monthly rate for May was approximately £38.10.0.

No. of Men Employed: The maximum number in the past was 160 men. This had fallen to 60 just before closing down.

Ore Reserves: The ore bodies in the main mine were practically worked out. Exploration on another possible orebody has been mapped out.

Average Conthly Throughout: During the final year an average of about 1,200 tons per month was treated. The capacity of the plant is 4,500 tons, and an average of 4,445 tons per month was treated in 1939.

Plant: Boilers, steam driven engines and compressors, winder, 20-hear battery, strakes, classifiers, ball mill, agitators, thickeners, filters, ginc boxes, assay room, etc.; sundry mine stores, water tanks, garage, timber shed, offices, change house, blacksmith shop, tool sharpening shop, 1 motor truck, 6 company houses. The valuation placed on the plant by the Company is \$48,400

Mine: The mine has been allowed to fill with water, which is within 40 feet of the surface. There is some doubt as to whether the mine will re-open to full scale production, although some exploration and development work is projected.

The total output from the property was 304,234 tons of ore for 155,375 ounces of gold. During the final year's work 5,536 ounces were produced from 14,695 tons of ore.

Requirements for Resential Maintenance: Almost entirely caretaking; occasional greasing and oiling.

Recommendation: One caretaker only be employed.
