SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 JANUARY 2024 – 31 DECEMBER 2024

Pursuant to the Senate Order for entity contracts the following table sets out contracts entered into by Geoscience Australia which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:
